

CARE CLUB® Q1 SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.

The Care Club® Q1 Sweepstakes (“Sweepstakes”) is sponsored by Johnson & Johnson Consumer Inc. (“Sponsor”), 199 Grandview Road, Skillman, NJ 08558 and is administered by Prize Logic, LLC, (“Administrator”), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on June 11, 2020 at 12:00 PM Eastern Time (“ET”) and ends on August 31, 2020 at 11:59:59 PM ET (“Sweepstakes Period”). The Sweepstakes Period includes three (3) Monthly Entry Periods (each a “Monthly Entry Period”) as set forth in the chart below, and one (1) quarterly entry period (“Quarterly Entry Period”) that will run for the duration of the Sweepstakes Period:

Non-winning entries will not carry forward into subsequent entry periods. The Administrator’s computer is the Sweepstakes official clock.

2. **ELIGIBILITY:** This Sweepstakes is open only to: (a) legal residents of the forty-eight (48) contiguous (including the District of Columbia), (b) who are at least eighteen (18) years old or age of majority in his/her state of residency, whichever is older at the time of entry and (c) who are Care Club® members. Membership is free. Employees of Sponsor, Administrator, Octagon Inc., The United States Soccer Federation, Inc. (“USSF”), the Women’s National Team Players Association (the “WNTPA”), the United States National Soccer Team Players Association (the “MNTPA,” and together with the WNTPA and the USSF, the “USSF Entities”), Major League Soccer, LLC (“MLS”), Soccer United Marketing, LLC (“SUM”) and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, “Sweepstakes Entities”) and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void in Alaska, Hawaii, and where prohibited or restricted by law.

Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant’s residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

- 3. HOW TO ENTER THE SWEEPSTAKES:** You must be a Care Club® member to enter. Membership is free. If you are not a member, please visit mycareclubrewards.com to become a member. During the Sweepstakes Period, an eligible entrant may visit mycareclubrewards.com (“Website”) and register by entering his/her e-mail address associated with his/her Care Club® membership. Eligible entrants may enter the Sweepstakes by either: (1) redeeming Points (as set forth in the Care Club® Rewards Terms and Conditions found at mycareclubrewards.com); or (2) the free mail-in method of entry as set forth below.

To receive Sweepstakes entries without redeeming Points, an eligible entrant may hand-write his/her complete first and last name (no initials), valid e-mail address, valid street address (P.O. Boxes not accepted), city, state, zip code, telephone number, and date of birth (MM/DD/YYYY) on a 3½”x5” card (“Mail-In Entry”) and mail it with sufficient postage to: The Care Club Q1 Sweepstakes, P.O. Box 251328, West Bloomfield, MI 48325. Entrants who submit a Mail-In Entry will receive one (1) entry into Sweepstakes. All Mail-In Entries must be postmarked and received by the applicable dates listed in the chart in Section 1. All Mail-in Entries for the Quarterly Entry Period must be posted marked by August 31, 2020 and received by September 8, 2020 in order to be eligible.

Mail-In Entries must be legibly hand-written by entrant. Mechanical reproductions, postage-due, Mail-In Entries mailed in an envelope or sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

If more than the stated number of entries is received from the same person, telephone number and/or e-mail address during the Sweepstakes, the entries may, at the Sponsor’s sole discretion, be disqualified.

- 4. RANDOM DRAWING:** On or around the dates set forth in the chart in Section 1, the Administrator will randomly select the potential winners from all eligible entries received during each applicable Monthly Entry Period. The Quarterly Entry Period prize winner will be randomly selected on or around September 9, 2020. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.
- 5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:**
- A. Monthly Entry Period 1 Prize (1):** The prize is a \$100 Visa® Gift Card. There will be one (1) prize available during Monthly Entry Period 1. The ARV of the prize is \$100.
- B. Monthly Entry Period 2 Prize (10):** The prize is an authentic signed United States women’s soccer team Jersey and two (2) signed Hero Cards. Specific signatures for the jersey and hero cards, as well as the size and style of jersey will be determined by Sponsor in its sole discretion. There will be ten (10) prizes available during Monthly Entry Period 2. The ARV of the prize is \$440.

C. Monthly Entry Period 3 Prizes (10): The prize is a four (4) regular season tickets (for winner and three [3] guests) to attend a Major League Soccer match. There will be ten (10) prizes available during Monthly Entry Period 3. The ARV of each prize is \$160. Match location will be determined based on the location of the winner. The prize consists only of the tickets to the match. Match date and seat location determined by Sponsor in its sole discretion. Sponsor is not responsible if event is delayed, postponed, or canceled for any reason. Winner will not receive compensation from Sponsor for tickets that the winner is unable to use due to cancellation of the event, but tickets may be subject to standard rain-check policies and procedures set by the issuer. Winner agrees that event admission is awarded pursuant to a revocable, nontransferable license that is personal to that applicable winner, and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated or otherwise conveyed. Sponsor reserves the right to remove or to deny entry to winner and/or his/her guest(s) if either winner or his/her guest(s) violates the previous restrictions or engages in a disruptive manner, or with intent to abuse, threaten or harass any other person at the event. **Travel, transportation, parking, lodging, meals, and any and all other cost or expenses not expressly set forth in these Official Rules are not included in the prize.**

D. Quarterly Entry Period Prize (1): The prize is a “get out & summer getaway”. Prize is awarded as a \$1,000 GiftCards.com Visa Gift Card. There will be one (1) prize available during the Quarterly Entry Period. The ARV of the prize is \$1,000.

E. Odds of Winning: The odds of winning a prize depend on the number of eligible Sweepstakes entries received during each Monthly Entry Period and during the Quarterly Entry Period.

F. General Conditions: There is a limit of one (1) prize per Monthly Entry Period per person. A person may win a Monthly Entry Period Prize and still be eligible to win the Quarterly Entry Period Prize. The GiftCards.com Visa Gift Card is issued by MetaBank®, Member FDIC, pursuant to a license from Visa U.S.A. Inc. The Visa Gift Card can be used everywhere Visa debit cards are accepted in the US. No cash access or recurring payments. Card valid for up to 84 months, funds do not expire and may be available after card expiration date, fees may apply. Card terms and conditions apply. MetaBank and Visa are not the sponsor of the Sweepstakes. Each winner is solely responsible for any federal, state and local taxes as well as any costs and expenses associated with prize acceptance and use not specified herein as being provided. Prizes are awarded “as is” with no warranty or guarantee, either express or implied. All prize details are at Sponsor’s sole discretion.

IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("AAA RULES"). THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
