Non-winning entries will not carry forward into subsequent entry periods. The Administrator’s computer is the Sweepstakes official clock.

2. **ELIGIBILITY:** This Sweepstakes is open only to: (a) legal residents of the forty-eight (48) contiguous United States of America (including the District of Columbia), (b) who are at least thirteen (13) years old or age of majority in his/her state of residency, whichever is older at the time of entry and (c) who are Care Club® members.
